2020 MPMA President Rich Hodgson opened the meeting at 11:30 AM, calling for any old business, being none, she opened the meeting to new business. Rich introduced MPMA's new Board of Director, Lance Watrin. Thanks, Lance, for your support of our association.

MPMA President Rich Hodgson asked for a roll call of those present.

Todd Leyse: Adam's Pest Control

Todd opened the discussion on the subject of Chapter 18B. Preemption and the Minnesota Department of Agriculture (MDA) delegation of pesticide regulatory authority. Chapter 18B is a follow up of legislative language proposed during the 2019 Legislative Session that would allow to delegate pesticide regulatory responsibilities to Minnesota cities of the first class, which includes Minneapolis, St. Paul, Rochester, and Duluth.

Todd noted that the driving force for the delegation language was pollinator protection. This is a false concern in that during calendar year 2019, MDA investigated only two possible bee kills due to

pesticides, one was agriculture related and the other was unsubstantiated. If the Minnesota Legislature were truly serious about pollinator protection, more bee habitat should be encouraged.

Todd mentioned that during 2019 Legislative Session, MPMA worked to defeat this language. The Minnesota House of Representatives passed legislation that included delegation language; however, the Minnesota Senate did not include this language in their final Agriculture Omnibus bill. The Minnesota House of Representatives and Minnesota Senate met in a conference committee where the language was defeated. Even though MPMA was successful in eliminating the delegation language, the Commissioner of the Minnesota Department of Agriculture did not take a position opposing the language.

Todd noted it is MPMA's understanding that this language will again be proposed during the upcoming Minnesota 2020 Legislative Session. MPMA and other pesticide applicator associations met on January 13 with the MDA Commissioner Thom Petersen and his staff. The goal of the meeting was to indicate support 18 B. Preemption and detail the concerns regarding delegation language. Hopefully, MDA Commissioner Petersen will better understand our concerns, and take a position in opposition to delegation language that may be introduced during the 2020 Minnesota Legislative Session.

The meeting was well attended with major agriculture organizations and associations whose members apply pesticides in the urban environment. The MDA Commissioner stated that he was impressed with the number of various organizations that attended the meeting expressing support for 18 B. Preemption and concern that MDA would consider delegation of pesticide authorities.

Todd mentioned that it was a lengthy meeting with excellent discussion.

At the close of the meeting, Commissioner Petersen did indicate that given the excellent regulatory work done by the Minnesota Department of Agriculture, cooperation, and compliance by the regulated clientele, he saw no need to delegate regulatory responsibilities.

Christine Wicks: Minnesota Department of Agriculture

Christine discussed the upcoming 2020 Association of Structural Pest Control Regulatory Officials (ASPCRO) Annual Meeting which will be held this summer in the Twin Cities. ASPCRO is a professional association comprised of structural pest control regulatory officials of any state. The annual meeting is attended by anyone interested in the regulation of the Structural Pest Control industry including local, state, and federal officials charged with the regulation of pesticide use within their respective jurisdictions, members of the regulated industry, pesticide safety educators and private enterprises. The meeting is scheduled for August 17-21 in Minneapolis.
